IMPLEMENTATION OF EARLY CASE  
RESOLUTION PILOT PROJECT.

ADMINISTRATIVE ORDER 2012-07

The Chief Judge of the Second Judicial District Court has authority to make administrative decisions pertaining to the business of the court; and

The Chief Judge of the Second Judicial District Court may adopt rules or regulations as are necessary for the orderly conduct of court business; and

The Chief Judge shall supervise case flow management and arbitrate conflicts between judges on case management and procedural policy disputes; and

The ADKT 411 Second Judicial District Court Indigent Defense Report neither authorizes nor prohibits a program for early case resolution; and

The ADKT 411 Nevada Indigent Defense Standards of Performance contemplate that attorneys "must have the flexibility to choose a strategy and course of action that ethically 'fits' the case, the client, and the court proceeding;" and

The ADKT 411 Nevada Indigent Defense Standards of Performance, Standard 4-9, contemplates "early case resolutions" as a component of plea negotiations; and

NRS 260.060 provides that "for cause" the "district court may, on its own motion or upon motion of the public defender or the indigent person, appoint and compensate out of county funds an attorney other than, or in addition to, the public defender to represent such indigent person at any

1 stage of the proceedings or on appeal in accordance with the laws of this state pertaining to the  
2 appointment of counsel to represent indigent criminal defendants;" and

3 NRS 171.188 provides that when a district judge determines a criminal defendant is indigent  
4 and entitled to defense at public expense, the judge may appoint the County Public Defender, State  
5 Public Defender, or if "other good cause appears" another attorney to represent the defendant's  
6 interests; and

7 NRS 7.115 through NRS 7.175 relate to safeguarding the public treasury from unnecessary  
8 appointments of private counsel; and

9 Early Case Resolution is an effective tool to manage criminal case processing; and

10 Early Case Resolution enhances public safety by providing prompt treatment of addictive  
11 persons, assists in jail management, reduces jail transportation costs, and results in substantial  
12 savings of public funds;

13 **IT IS HEREBY ORDERED:**

14 1. The Second Judicial District Court shall implement an ECR Pilot Program to  
15 commence on July 1, 2012, and end on December 31, 2012, unless extended by further  
16 administrative order.

17 2. The ECR Pilot Program, which removes select criminal cases from the normal  
18 criminal case flow progression and expedites them to resolution while concomitantly protecting the  
19 defendant's constitutional rights, constitutes good cause for appointment of Washoe Legal Services  
20 to represent indigent defendants in criminal cases assigned to the ECR Pilot Program.

21 3. The presiding judge, on a case-by-case basis, shall determine whether WLS counsel  
22 will represent an indigent defendant as co-counsel with the Washoe County Public Defender. In the  
23 event WLS counsel is appointed as co-counsel, the Washoe County Public Defender shall have no  
24 further responsibilities until such time, if ever, the case is removed from the ECR Pilot Program. If  
25 at any time before entering a plea, the presiding judge determines the case should be withdrawn  
26 from the ECR Pilot Program, the judge will relieve WLS counsel and direct the Washoe County  
27 Public Defender to represent the indigent defendant in all further proceedings.

1           4.       Departments 3, 6, and 9 shall participate in the ECR Pilot Program unless substitute  
2 or additional departments are designated by the Chief Judge.

3           5.       Judge Adams is designated as Chair of a three-judge ECR Court Committee  
4 comprised of Judges Polaha, Freeman, and Adams. The Committee shall meet and implement  
5 program details, such as counsel appointments, forms, and calendaring, proposed by the Washoe  
6 County District Attorney. Court Administration shall be available to assist the ECR Court  
7 Committee. The ECR Pilot Program shall be administered by the Washoe County District Attorney  
8 with the cooperation of Washoe Legal Services. Funding for Washoe Legal Services' costs during  
9 the ECR Pilot Program will be by Washoe County, as previously approved by the Washoe County  
10 Commission on June 28, 2011. The undersigned Chief Judge is informed the source of payments  
11 shall be from an account already designated and funded for the purpose of providing tertiary public  
12 defense expenses.

13           6.       Further details of the ECR Pilot Program shall be as follows:

- 14           a.       The Washoe County District Attorney shall determine criminal cases  
15                 appropriate for assignment into the ECR Pilot Program. The final assignment  
16                 decision shall be made by the District Attorney pursuant to his prosecutorial  
17                 discretion. Categories of cases qualifying for ECR case processing shall be  
18                 periodically reviewed by the Washoe County District Attorney in  
19                 consultation with Washoe Legal Services.
- 20           b.       The initiation of an ECR criminal case shall be made by direct filing of the  
21                 information in the Second Judicial District Court.
- 22           c.       If at any time prior to entering a plea the defendant elects not to enter a plea  
23                 consistent with plea negotiations, or if the defendant chooses to withdraw  
24                 from the ECR Pilot Program, or if the presiding judge declines to accept the  
25                 plea after canvassing the defendant, the matter shall be remanded to the  
26                 Justice Court for further proceedings.


